How does a practice know if the Medical Decision Making for a particular patient visit is Medically Appropriate?

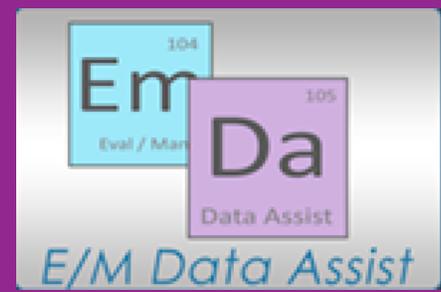
From 1997 until the end of 2020 an E/M code for an office visit for a new or established patient was determined from three categories of information

- History of the patient, including Family History, Social History, Medical History, History of Present Illness (HPI), Review of Systems and Problem List
- Exam performed on patient
- Complexity of the treatment associated with the chief complaint the patient listed as the primary reason they felt an appointment with the physician was necessary
